Drug-free Workplace Testing

We understand that a healthy, productive workforce begins with a drug-free workplace. Our comprehensive menu of regulated and non-regulated, laboratory-based tests as well as rapid test options are designed to meet the needs of most workplace testing programs. Drug testing options include urine, oral fluid, hair, and blood.

Rapid Tests

Our rapid drug screening tests may help to increase productivity by reducing time to hire. Rapid Tests provide on-site screening for drugs of abuse, urine specimen validity, and saliva alcohol, following chain-of-custody protocol. For convenience and accessibility, multiple rapid test options are available in many of LabCorp's patient service centers (PSCs) nationwide, also offering an electronic chain-of-custody process.* For employers who choose to perform the tests in their own facilities, a variety of rapid testing products are available. Our certified laboratories offer confirmation testing for nonnegative rapid test drug screens.

Employee Health and Safety Assessments

Our employee health assessment programs are designed to complement employee wellness initiatives and offer on-site workplace events and remote screenings that can include a blood collection for a comprehensive health panel, biometric screening, nicotine screening, employee wellness education, health coaching, and support services.

For employees who cannot attend an on-site screening event, LabCorp provides biometric screening through select company-owned and operated PSCs. LabCorp's biometric screening includes height, weight, blood pressure, waist circumference, body mass index (BMI), and blood draw for wellness screening. For employees who do not have access to these two options, LabCorp offers a collect at home kit. Our Lab-in-an-Envelope® program is a cost-effective alternative when access to phlebotomy services may not be an option.

Lab-in-an-Envelope®

Lab-in-an-Envelope uses dried blood spot specimens that the employee collects at home. Each Lab-in-an-Envelope kit contains all the items required to collect, prepare, and mail the dried blood specimen to the laboratory via US mail. Test options include: total cholesterol, triglycerides, HDL cholesterol, LDL cholesterol, estimated average glucose (eAG), hemoglobin A1C, prostate specific antigen (PSA), and thyroid stimulating hormone (TSH).

Diagnostic and Preventive Tests

We have the ability to customize employee assessments to meet the needs of your organization's employee population. Our comprehensive menu of diagnostic and preventive tests can be combined to achieve your organization's employee wellness objectives.

Biological Monitoring and Exposure Testing

We offer a comprehensive menu of biological monitoring and exposure testing conducted in our OSHA-certified laboratory. These tests are designed for monitoring workplace exposures to toxic metals and chemicals, including lead, mercury, arsenic, and cadmium, as well as benzene, toluene, PCBs, halogenated hydrocarbons, and chlorinated pesticides.

Fingerprinting Services

Fingerprinting services are offered to assist organizations that must submit fingerprints to the FBI for background purposes or for those that choose to conduct fingerprint-based background searches due to the speed and scope of search results.

Industrial Allergy Testing

Reactions to latex, adhesives, or chemicals can result in employees who cannot work at full potential, increased absenteeism, and additional health care expenses. Our industrial allergen testing can assist in identifying allergies to prevent lost productivity and allergy-related health care costs.

For customer convenience, select PSCs offer fingerprint capture, specimen collection, and biometric screening. Our National Specimen Collection Network provides additional coverage through third-party facilities, assuring that your employees are never far from a network facility.

National Specimen Transportation Network

For timely results, we can arrange direct specimen pick-up from most geographic areas through LabCorp's national, company-owned courier network or a contracted courier.
